## Questions from the Financial Aid Office

Please answer the following mandatory questions to view your financial aid awards.

#### TITLE IV AUTHORIZATION

By answering **YES** to the Title IV authorization you give CSC permission to use your financial aid to pay **all** of the charges on your student account. If you say **NO**, only your tuition, fees, room and board will be paid. All other charges, such as textbooks, parking fees, ID cards, etc, will **not** be paid by your financial aid and **you** will be responsible for paying those charges **from your own funds**. Title IV funds include PELL, SEOG, and Federal Direct Student Loans.



By answering **YES** to the Prior Year Charges, you give CSC permission to use your financial aid to pay up to \$200 of prior-year incidental charges on your account. If you answer **NO** those charges will not be paid and you will be responsible for paying those charges. If at the end of the aid year, your financial aid was not enough to cover all of your charges, you will be responsible for those charges. However, if the remaining balance is less than \$200 by selecting **YES you allow our office to pay for those charges in the next aid year.**

Awards are also subject to change based on final congressional funding appropriations. To receive student loans, undergraduates must be enrolled in at least 6 hours. Students must be degree seeking to be eligible for any federal student aid. Students are required to meet satisfactory academic Private Stud progress and must not owe a federal grant repayment or be in default on a federal student loan to be eligible for federal student aid. CSC's Satisfactory Academic Progress Policy can be found on our website.
