**SPRING ENTRY: Between April 15 - October 1**

## DESCRIPTION

The Career Ladder Program for Nursing at Connors State College is especially designed to provide mobility for the Licensed Practical Nurse and the Licensed Paramedic. Qualified individuals may earn up to 18 hours of advanced placement toward an Associate of Applied Science in Nursing.

## ADVISEMENT

All students declaring a nursing major are assigned to the Department of Nursing for advisement. Students may schedule an appointment to speak to a nursing advisor by going to the Connors website and clicking on the “campus tours/advisement” link. Next “click here to schedule an advising appointment”. Select the Pre-Nursing Advisor and make an appointment. Pre-Nursing students should visit with a nursing advisor early in their course work. Early pre-enrollment is encouraged. For more information about the nursing program, you may call (918) 684-5436, or come to the nursing office between 8:30 a.m. to 12 noon or 1:00 p.m. to 4:00 p.m. while school is in session. The CSC Nursing Program is located at the Muskogee – Three Rivers Post Campus (Nursing and Allied Health Facility), 2501 North 41<sup>st</sup> Street East, Muskogee, OK.

## TECHNOLOGY REQUIREMENTS

This program requires extensive use of technology including required textbooks delivered as e-books, paperless clinical documentation, and regular interface with the online classroom. For this reason, students accepted to the program must have a computer and internet access at home. You will purchase your laptop through Connors. You will use this device during class time and in the clinical setting. ***Once you accept this device it cannot be returned to the college. No other alternative device will be allowed for use during class or in the clinical setting.*** The device may be purchased with the use of financial aid or a payment plan through the college.

## APPLICATION TO THE PROGRAM

Students submit an application to the program during the designated time frame. A new application must be received for each application period; even if the student has applied to the program before they **MUST** submit a **NEW** application. All applications **MUST** be signed and dated with the required supporting documents as listed on the application form.

## ADMISSION TO THE NURSING PROGRAM

Students wishing to be considered for the program must meet the admissions requirements to Connors State College and have the following data in their file by the final closing date of the application period:

1. Nursing Application signed and dated with required supporting documents (official or copies of all transcripts from previously attended colleges and HESI Nursing Admissions Assessment Exam results and HESI LPN-ADN Mobility Exam results). If the student has been an LPN for less than a year, they do not have to take the HESI LPN-ADN Mobility Exam. It is the student's responsibility to make sure all documents are submitted with application.
2. Minimum scores required for the "HESI Nursing Admission Assessment Exam"
  - Reading 70%
  - Math 65%
  - Science 70%
  - The HESI Nursing Admissions Assessment Exam is administered in the nursing department at \$60.00 per exam. (*Testing fees are non-refundable and subject to change.*)
  - The HESI Nursing Admission Assessment Exam can be taken only twice per application period. Completed test results will be valid for up to two (2) years. Only the latest test and all results from that test will be used.
3. Verification of Oklahoma nursing or paramedic license, without restrictions.
4. Passing grade on HESI LPN-ADN Mobility Exam (*applicants within one year of completion and licensure as an LPN will be exempt from taking the HESI exam*). The HESI LPN-ADN Mobility The exam can only be taken two (2) times. Completed test results will be valid for up to two (2) years.

*Students applying to the CSC Nursing Program are selected on the basis of a point system. No student is guaranteed admission to the nursing program.*

It is strongly recommended that all of the support courses be complete before beginning Maladaptive States I. To be considered for admission to the program, students will have to maintain a minimum grade point average of 2.5 in required general education and support courses. **A student cannot be considered as a candidate for selection with a "D" in any required courses on transcripts for current application period.** Successful completion of the nursing program requires a "C" in all courses related to the Associate in Applied Science in Nursing Degree.

## ENTRY LEVEL ASSESSMENT AND PLACEMENT

Entry level assessment for the appropriate course placement of students is conducted using ACT score and Accuplacer. Sub scores or subject scores on these assessments may trigger the use of multiple measures including high school GPA and successful high school subject completion within the last seven (7) years.

As part of the advising process, student ACT scores (when available) and high school preparation are considered when determining course placement and the need for remedial coursework. If no ACT score is available, or seven (7) years have passed since the student took the ACT, students take the Accuplacer course placement exam to assess proficiency in reading, English, and mathematics.

Those students obtaining scores in the college-level range will have demonstrated competency and may pursue college-level course work, while those students with scores below the college-level range will be placed in remedial courses or credit bearing corequisite courses with developmental lab work to improve skills in one or more of the following: reading, English, and math.

## HESI NURSING ADMISSION ASSESSMENT EXAM

The “**HESI Nursing Admission Assessment Exam**” will be given in the nursing department’s computer lab. The student is required to register for the HESI Nursing Admission Assessment Exam **online**. To register for the “HESI Nursing Admission Assessment Exam” go to <http://www.connorsstate.edu/nursing>. Then on the Nursing Links page select “HESI Nursing Admissions Assessment Test Dates”. You will need to fill out a pre-registration form with the nursing department. This is where you will select the date that you want to take the exam. Carefully read all instructions, then complete and submit the registration form via email as instructed. **NOTE: student will receive a confirmation notice after email is sent; noting the date/time of exam when scheduled, and the cost of the exam.** If you do not receive a confirmation email, please call (918)684-5436 to see if the pre-registration form was received. To cancel a scheduled exam the student should notify the nursing department first, and then reschedule the exam online by selecting an alternate date.

The HESI Nursing Admission Assessment Exam is administered on the *3<sup>rd</sup> Thursday of each month starting at 1:00 p.m.* throughout the application period (see important HESI Nursing Admissions Assessment Test dates listed on the CSC Nursing Program website <http://www.connorsstate.edu/nursing> and select “*HESI Nursing Admissions Assessment Test Dates*” to see the exam dates at the bottom of the page.

Students must bring the completed registration form for their ticket to the test. Students without a completed registration form will not be allowed to take the test. It is recommended the students arrive 30 minutes early for registration. Once the exam begins no one will be allowed in the room. Students arriving late will not be permitted to test. **It is recommended that all personal items (cell phones, purses, school bags, etc.) be left in your vehicle**, otherwise they will be left in the Coordinator of Nursing and Allied Health office during the testing.

## HESI LPN-ADN MOBILITY EXAM

The “**HESI LPN-ADN Mobility Exam**” will be given in the nursing department computer lab. The student is required to register for the HESI LPN-ADN Mobility Exam **online**. To register for the HESI LPN-ADN Mobility Exam go to <http://www.connorsstate.edu/nursing> and select the title “*HESI LPN-ADN Mobility Exam Test Dates*” under the frequently used links. Carefully read all instructions, then complete and submit the registration form via email as instructed. **NOTE: student will receive a confirmation notice after email is sent; note the date/time of exam when scheduled.** If you do not receive a confirmation email, please call (918)684-5436 to see if the pre-registration form was received. To cancel a scheduled exam the student should notify the nursing department first, and then reschedule the exam online by selecting an alternate date.

The HESI LPN-ADN Mobility exam is administered on the 4<sup>th</sup> *Thursday of each month starting at 1:00 p.m.* throughout the application period (see important HESI test dates listed on the CSC Nursing Program website <https://connorsstate.edu/nursing/welcome/hesi-lpn-adn-test-dates/>). Students must bring the completed registration form for the ticket to test and \$62.00 (cashier check or money order) for testing fee. (*Testing fees are non-refundable and subject to change.*) Students without a completed registration form and fees will not be allowed to test. It is recommended the students arrive 30 minutes early for registration. Once the exam begins no one will be allowed in the room. Students arriving late will not be permitted to test. **It is recommended that all personal items (cell phones, purses, school bags, etc.) be left in your vehicle**, otherwise they will be left in the nursing department's coordinator of nursing and allied health office during the testing. **To be eligible for admission consideration to the nursing program the student must score 800 or above on the HESI LPN-ADN Mobility Exam.**

### **DOSAGE CALCULATION EXAM**

The challenge exam for NURS 1132 Mathematics for Nurses will be given in the nursing department. Call (918)684-5436 to schedule an appointment in Muskogee.

The exam must be passed with at least a 90% accuracy to demonstrate that the applicant has met the following course objectives: Make sure the objectives follow Mathematics for Nurses Objectives

1. Demonstrate ability to utilize Roman numerals, fractions, decimals, ratio and proportion, and percentages in calculating dosages.
2. Convert within and between metric, and household systems of measurements.
3. Demonstrate ability to read and interpret medication orders.
4. Accurately calculate dosages using dimensional analysis methods.
5. Calculate oral and parenteral dosages.
6. Calculate intravenous flow rates.
7. Calculate pediatric dosages using mg/kg.
8. Calculate critical care dosages for pediatric and elderly population.

LPN's and paramedics must pass the HESI Nursing Admission Assessment Exam Math at a 70% or above prior to enrolling in NURS 1132 Math for Nurses. LPN's and Licensed Paramedics may elect to take NURS 1132 Math for Nurses concurrently with NURS 2333 Transitions to Professional Nursing. The math challenge exam may be attempted three (3) times. LPN's and Licensed Paramedics who do not achieve the required 90% or above after the third attempt will need to take NURS 1132.

### **PHYSICAL AND MENTAL REQUIREMENTS FOR PARTICIPATION IN THE DEPARTMENT OF NURSING**

The following essential physical and mental requirements are necessary to be considered for admission into and progression through the Connors State College Nursing Program but are not limited to:

1. The ability to lift weights of up to 35% of recommended body weight independently.
2. The ability to move around the clients' rooms and in work areas to administer various procedures.
3. Visual acuity sufficient to observe and assess client behavior, prepare, and administer medications, and accurately read monitors.
4. Auditory acuity sufficient to hear instructions, requests, and monitoring alarms, and to auscultate heart tones, breathe sounds, and bowel sounds.
5. The motor ability necessary to manipulate equipment and supplies and to utilize palpation and percussion in client assessment.

6. Communication abilities sufficient for interactions with others in verbal and written form such as explaining treatment procedures, initiating health teaching, documenting, and interpreting nursing actions and client responses.
7. The ability to communicate in a professional manner, establish rapport with clients and colleagues, use problem solving skills, and function effectively under stress.
8. Perform within a crisis situation providing care to meet physical, emotional, or psychosocial needs of the patient/client.
9. Critical thinking abilities sufficient for clinical judgment to identify cause/effect relationships in clinical situations.

### **CLINICAL RECORDS**

After acceptance into the program students will need to provide documentation of the following:

1. Proof of two (2) MMR's or positive titer for measles, mumps, and rubella.
2. Hepatitis B three (3) series, titer, or signed declination form.
3. Proof of two (2) Varicella vaccines or a positive varicella titer.
4. Tetanus/Diphtheria/Pertussis (Tdap) vaccine within the last 10 years.
5. Current influenza vaccination. Flu season is from October to February. Students entering in fall should not receive their flu shot until October 1. Students entering in January should receive their flu shot between October 1 and January 1.
6. Tuberculosis (ppd) testing showing negative status yearly. Students with history of positive TB test will need a chest x-ray every 5 years and an approval for public contact from the Health Department or healthcare provider. Quanti-Ferron lab work indicating immunity is also acceptable.
7. COVID-19 immunization status. Original vaccinations and any available booster should be included.
8. American Heart Association (AHA) current CPR/BLS certification which must include adult, child, and infant.
9. Negative Federal Criminal Background check (sex-offender is included).
10. Negative Drug Screen

### **BLENDED CLASSES**

Career ladder students use a combination of conventional classroom meetings with independent study via the Internet and e-mail. Students must have access to a computer and the Internet and possess basic Internet skills. It is important to be familiar with MS Windows environment, be able to manipulate files/folders and use Microsoft Word Processing.

### **FINANCIAL AID**

### **PLAN FOR SUCCESS**

Because of the vital nature of nursing, this is a demanding program of study. Success depends primarily on adequate preparation and planning. The following suggestions are offered to help assure success:

- Complete support courses before beginning the nursing courses. Anatomy & Physiology I, Anatomy & Physiology II, and Microbiology are particularly important to provide a knowledge base for understanding nursing concepts.
- Plan three to four hours' study time each week for each credit hour in which you are enrolled. Example: Students enrolled in 12 credit hours should plan 36 hours of study time each week, in addition to class and lab time.
- Consider enrolling in NURS 1002 Success in Nursing Education.

**STUDENT SELECTION CRITERIA FOR ADMISSION INTO THE LPN/PARAMEDIC CAREER  
LADDER PROGRAM**

Students applying to the Connors State College Nursing program are selected on the basis of a point system. No student is guaranteed admission/acceptance. All courses below must be completed with course grades posted on an official transcript. No points will be given for a course “in progress.” Points are awarded for the scores received on the “HESI Nursing Admission Assessment Exam.” Student must obtain a minimum of 70% in Reading; 70% in Math; and 70% in Science to be considered for the nursing program. Also, completion of general education and support courses with a “C” or better, completion of any 4 recommended electives with a “C” or better, Connors State College course work only, GPA, and a degree in another area. The specific points awarded are shown below.

## **Notice of Oklahoma Board of Nursing Rule Change Regarding Criminal Offenses and Background Checks**

“The Nursing Program at Connors State College is approved by the Oklahoma Board of Nursing. Graduates of this state-approved program are eligible to apply to write the National Council Licensure Examination (NCLEX) for (registered or practical) nurses. Applicants for Oklahoma licensure must meet all state and federal requirements to hold an Oklahoma license to practice nursing. In addition to completing a state-approved nursing education program that meets educational requirements and successfully passing the licensure examination, requirements include submission of an application for licensure, a criminal history records search, and evidence of citizenship or qualified alien status [59 O.S. §§567.5 & 567.6]. To be granted a license, an applicant must have the legal right to be in the United States (United States Code Chapter 8, Section 1621). In addition, Oklahoma law only allows a license to be issued to U.S. citizens, U.S. nationals, and legal permanent resident aliens. Other qualified aliens may be issued a temporary license that is valid until the expiration of their visa status, or if there is no expiration date, for one year. Applicants who are qualified aliens must present to the Board office, in person, valid documentary evidence of:

1. A valid, unexpired immigrant or nonimmigrant visa status for admission into the United States;
2. A pending or approved application for asylum in the United States;
3. Admission into the United States in refugee status;
4. A pending or approved application for temporary protected status in the United States;
5. Approved deferred action status; or
6. A pending application for adjustment of status to legal permanent resident status or conditional resident status.

The Board has the authority to deny a license, recognition or certificate; issue a license, recognition or certificate with conditions and/or an administrative penalty; or to issue and otherwise discipline a license, recognition or certificate to an individual with a history of criminal background, disciplinary action on any professional or occupational license or certification, or judicial declaration of mental incompetence [59 O.S. §567.8]. These cases are considered on an individual basis at the time application for licensure is made. Potential applicants to state-approved education programs, with a criminal history, may obtain a determination of eligibility for licensure or certification from the Oklahoma Board of Nursing for a fee.
